 - 👢 In the case of a double-course Engineering course / Master course, the registration in the Engineering course is considered as the main registration whose fees are to be payed at the full rate; the lowered rate of the tuition fees applies as for it to the Master course whose registration is then taken into account as a second registration.
- Partial exemption bringing the amount of the registration fees, owed by the non-EU students, to the amount that applies to EU students:
- for the whole period of the university course of the non-EU students registered at the institution for the acdemic year 2019/2020
- only for the academic year 2020/2021 for the non-EU students who register for the 1st time at the institution. These students will have the means to ask for an exemption of the differenciated registration fees by submitting a demand file to the Social Student Committee when they will reregister next academic year (2021/2022)

 - ▶ in the case of the use of a "E-credit card ", the payment by instalments is not possible
