#### BEFORE STARTING THE APPLICATION:

Please contact the registrar's office of your training department to obtain access to the campaign.

#### **▲ IMPORTANT ▲**

Each copy of a financial document issued abroad must be certified as a true copy of the original.

Proof of family income must clearly indicate the identity of the person concerned and the ANNUAL TAXABLE amount of the incomes received in 2024. In the case of a change in the situation, the incomes for 2025 are requested.



All documents must be translated into French or English (sworn translations are not compulsory).

Any application that is INCOMPLETE, or that includes financial documents that are not certified as true copies of the originals, are not translated, are illegible, and/or do not correspond to what is requested, will be rejected.

The PDF format is required, or JPEG for images (photos, scans).

For foreign incomes, the amount of the financial incomes of the parents or legal representatives, indicated in the currency of the home country, will be converted in euros using the official exchange rate which will be published at the time of the application's review.

#### **BEFORE STARTING**

- 2- Please download all supporting documents and add the completed and signed "List of required documents".



If your family situation does not allow you to provide all the supporting documents, please contact the registrar's office of your department.



#### STUDY FUNDING

All financial resources planned for the academic year 2025-2026 must be declared, and all scholarship and/or funding applications must be submitted, even if the answer is in progress.

Please note: Without this document, your application will be rejected.

**FOREIGN RESOURCES**: Parents or legal representatives with incomes abroad regular or irregular (employment, rental income, social aid, etc.)

#### Please provide the following supporting documents:

The LAST NAME and First name of the person concerned must be indicated, as well as the annual taxable amount, and written in the currency of the country of origin.

#### Proof of annual incomes received in 2024

⇒ Tax notice 2025 for incomes received in 2024

#### OR

⇒ Employer's certificate specifying the LAST NAME and First name of the person concerned, the annual TAXABLE amount of income received in 2024 (written in figures and in words) before any tax deductions (taxes and/or credits, if applicable) and written in the currency of the country of origin.

#### And depending their situation:

⇒ Certificate of other incomes received from January 2025 to July 2025 such as unemployment benefits, solidarity allowance, retirement pension, property income, disability allowance, family allowances, etc.

#### Parents or legal representatives do not receive any incomes

#### Provide the following supporting documents:

- ⇒ Full copy of all pages of the non-taxation notices of the year 2025
- ⇒ Certificate of non-income issued by the Directorate-General of Taxes
- ⇒ Official certificate of no financial resources
  - → Examples: solidarity resources, widow's pension, property income, etc...

Please note: Without this document, your application will be rejected.

#### Parents or legal representatives with a change of situation in 2024 or 2025

If one of your parents or legal representatives experienced a **significant change in their situation** in 2024 or 2025 such as: *divorce, redundancy, unemployment, long-term illness, disability, etc.* 

#### Please provide the following supporting documents:

- ⇒ Official document proving the change and its impact on the family income.
  - → Examples of accepted supporting documents: Unemployment certificate, dismissal letter, divorce decree or separation certificate, disability notification, any other recent official document proving the loss of income
- ⇒ Any other recent official document proving a decrease in the incomes

#### **AND**

#### Proof of your current situation at the time of submitting your application:

This document must show the evolution of the initial change and allow for an assessment of your new income (or lack of resources).

- → Examples of accepted supporting documents: Employment certificate specifying the start date and monthly salary, latest monthly certificate from France Travail if you are still unemployed, new employment contract, recent disability notification with or without compensation.
- ⇒ Any other equivalent document justifying the current situation and the resources received (or their lack)

Without complete supporting documents, the new financial situation cannot be taken in consideration in the review of your file.

#### **BANK STATEMENT**

⇒ Official bank details provided by your bank in France with your FULL NAME and Surname and including your address in France during the academic year 2025-2026.

#### **DECLARATION OF HONOR**

#### According to Article 441-6 of the Code of Criminal Procedure:
